

1. PURPOSE

The purpose of this report is to provide an overview of the state of finances. This report uses actual information from the latest information from the municipal In-Year financial monitoring system (i.e. section 71 reports).

2. BACKGROUND

In terms of section 71(6) of the Municipal Finance Management Act (Act 56 of 2003) (MFMA), the Provincial Treasury must, within 22 days after the end of each month submit to National Treasury a consolidated statement on the state of the municipalities' budgets per municipality and per municipal entity. Furthermore, section 71(7) requires that, Provincial Treasury must, within 30 days after the end of each quarter, make public as may be prescribed, a consolidated statement in the prescribed format on the state of municipalities' budgets per municipality and per municipal entity. The MEC for Finance must submit such consolidated statement to the provincial legislature no later than 45 days after the end of each quarter.

3. METHODOLOGY AND APPROACH

The methodology and approach used for the compilation of this report included the following:

The data for the analysis used in this report was extracted from the National Treasury Local Government Database. (Section 71(1) requires the Municipal Accounting Officer *"by no later than 10 working days after the end of each month submit to the Mayor of the municipality and the relevant provincial treasury a statement of the municipalities budget performance in a prescribe format..."*

Section 71(2) states that provincial treasury must, within 30 days after the end of each quarter, make public as may be prescribed, a consolidated statement in the prescribed format on the state of municipalities' budget per municipality and per municipal entity. The MEC for finance must submit such a consolidated statement to the provincial legislature no later than 45 days after the end of each quarter.


- Municipalities have on average raised 86 percent revenue of the adjusted budget.




Breakdown of Revenue by District per Source - June 2018




Breakdown of Expenditure by District per Source - June 2018





- Water and sanitation contributed 53 percent of the capital expenditure


Breakdown of Capital Sources by District per Source - June 2018




Breakdown of Capital Expenditure by District per Source - June 2018




Capital Sources of Finance - June 2018





- Municipalities are generally dependent on Grants; which constitutes an average of 59 percent of the total receipts in the province.
- Property rates constitute an average of five per cent on the total receipts.
- Electricity revenue collected is nine percent of total receipts and electricity bulk expenditure is 12 percent of the total expenditure for the quarter.
- The total receipts for the quarter exceeded the total expenditure paid by R2.5 billion.


Cash Receipts per district by Source- June 2018




Cash Payments per District by item - June 2018

- Households are the major contributor of outstanding debtors at 64 percent, followed by other debtors at 20 percent.





Debtors Age Analysis - Provincial Overview




Debtors by Customer Group - June 2018




Creditors Age Analysis - June 2018




Creditors by Customer Group June 2018
