Limpopo Provincial Treasury (LPT) hosts the small businesses Imbizo

he honourable Member of the Executive Council (MEC) for Provincial Treasury, Sa'ad Cachalia invited small businesses in the Waterberg district, to an Imbizo aimed at empowering them with knowledge on the public sector procurement.

This took place today (12 August 2010) at the Phagameng Community Hall, outside Modimolle.

The occasion was graced by the presence of the Mayor for Modimolle Local Municipality, Councillor Kgaretja Lekalakala and Ms Julia Modela representing the Waterberg District Mayor.

As part of the proceedings, the representative of small businesses were given an opportunity to get clarification on areas including pricing and costing, compliance with receiver of revenue for tendering, contract performance monitoring and the role that Treasury plays in public finance management.

MEC Cachalia stressed that "Treasury's role is to minimise any possibility in our system for corruption. We monitor good governance as represented by adherence by all government institutions to the prescriptions of the Public Finance Management Act (PFMA), the Municipal Finance Management Act (MFMA) and other relevant legislation". MEC Cachalia also indicated that the centrality of women in the fight against poverty and their participation in the economic activities of the province through access to Supply Chain

The South African economy is ranked number 32 in the world

- The inflation rate in May 2010 is at 4.6%. Exports are at R67bn and are mostly with the Middle East, Africa and Asia. Major partners are the United States (US), China, Germany and Netherlands.

Unprecedented improvement in public finance management

- The Public Finance Management Act (PFMA), 1999 for national and provincial government and the Municipal Finance Management Act, 2003 for the local government sphere were passed and have put our country on a path where every expenditure made has to be accounted for. This has led to unprecedented improvement in the financial management of all state institutions."
- In the auditing process the matters of emphasis have been a central feature due to the thorough reporting requirements
- Corruption in the public sector has been dealt a serious blow over the years. Various Anti-corruption initiatives have made space very impossible for this. The Prevention and Combating of Corrupt Activities Act, 2004 paved the way for faster and more efficient methods to deal

with corruption with over 900 commercial crime trials in 2005/06 finalised with a conviction rate of over 94%.

The Public Service has trans-formed remarkably.

- It reflect the demography of our country. Africans are 72% of the service at all levels, but there is still a need for more persons with disability and women in senior. The proportion of white public servants has declined by 2%.
- Government has also put a lot of effort into Education and skills development.
- The Expanded Public Works Programme (EPWP) has created temporary work opportunities for on-the-job training to improve partakers' chances of sustainable employment. Indeed, we have come a long way.
- Government has made progress in a number of areas that affect people's social status. Poverty has

Government visits GaNthata

he Limpopo Provincial Government's Executive Committee (Cabinet) visited the community of GaNthata in the Mopani district. This took place on Friday, 29 July 2010. The purpose of this visit was to give members of this community an opportunity to influence government programmes and services delivered to this area.

Provincial Treasury, together with the department of Economic Development, visited the Prada brick making project. It is owned by eight (08) people who produce bricks with their "self-made block forms". Mr James Raboroko indicated that their major challenges include absence of vehicles to transport their products to buyers, poor access to water, and lack of fencing for their facility. Provincial Treasury provides advice on how these small businesses can benefit from the government's procurement system. During the main ceremony,

representatives from the taxi industry praised the efforts that government has employed in uplifting their business.

They were elated with the opportunity to participate in the destination branding for South Africa, especially during the 2010 Soccer World Cup. "Govern-ment must continue with the training on customer care that our taxi industry is receiving", said Hlungwani.

According to their spokesperson, Mr Raid Hlungwani, their participation included transporting fans to the Public Viewing Areas (PVAs) and the stadiums. They, however, indicated that there was an urgent need to improve some of the road infrastructure including "building bridges and tarring certain gravel roads".

The youth requested for government's intervention in managing the access of the young people, especially learners at schools. This, they suggest, can be

solved by creating a safe distance between the schools and drinking places like "taverns".

The meeting agreed that community members cannot afford to sit back and watch when some elements are creating a bad image about South Africa being xenophobic. The people of GaNthata will work against these bad attempts and have committed to live harmoniously with all members of the community regardless of their places of birth.

"An improvement is necessary in the promotion of access to persons living with disability, whether in government institutions or the private sector", said Mr Sello Mathe.

In his closing remarks, Premier Cassel Mathale reminded people of GaNthata of the importance of leadership in realising the challenges that communities face. "Government can only deliver appropriately when members of the community take an active participation in the management and execution of these gains",

The Limpopo Provincial Government intends to visit other communities during the course of the year.

The stadium was fully packed with the learners and teachers from both private and public schools from all around all corners of Limpopo Province, including special schools for persons living with disabilities.

The function started at 09h30, and was officially opened by the Vice-Chancellor and Principal of the university, Professor Mahlo Makgalong.

Mr. Kgalema Mohuba was the Programme Director for the gathering, calling one school after the other and leading the learners of those schools to get into the marquee tent to receive information concerning their career prospects.

Treasury said the recommendations were aimed at improving the quality of banking services to customers as well as improving the retail banking environment as well as transparency.

The minister described the talks between the banking sectors as "an important milestone".

"The theme running through all of these recommendations is transparency. There must be transparency of all of the charges, they must be writen in an understandable language and communicated in way that people can compared A, B and C and then linked with this is the ability by consumers to make choices," explained Gordhan.

Regarding other outstanding recommendations, Treasury said discussions were to continue.

The minister also added that there was a need for more active consumer groups who would put pressure on banks to lower their fees. – *BuaNews*

Business Confidence improves from recession

Pretoria - South Africa's Business Confidence Index (BCI) in July recorded the second highest reading this year at 84.3 points, the South African Chamber of Commerce and Industry (SACCI) said.

The July figure of 84.3 points is 1.1 point above the July 2009 level following on June 2010's 84.8 points.

"The figure has improved from the recession but it is still not good enough at the moment," said SACCI economist Richard Downing of the BCI'S composite weighted index of 13 sub-indices that include new vehicle sales and merchandise import and export volumes.

According to the chamber, the month of July 2010 renewed focus away from the sentiment of the World Cup and returned it to the economic reality of a domestic economy struggling to gain momentum.

The global economy also reflected tensions as the pace of positive financial market developments outpaced a lagging real economy, SACCI said, adding that business confidence has yet to perceive strong and real economic prospects.

"If July 2010 is compared to June 2010 (month on month) five sub indices of the BCI were positive, four were negative and four remained neutral," said the chamber. Sub-indices of the volumes of merchandise exports as well as imports recorded a relative strong performance compared to previous months.

"The Soccer World Cup 2010 was an exceptional success and although it raised expectations during June 2010, a special effort is required to sustain the positive momentum and enhance the business outlook. Stronger domestic demand and stronger posturing in the international trade environment are necessary to promote sustained improvements in business confidence."

SACCI said that relative to July 2009, eight of the BCI sub-indices improved with real retail sales and building construction still lagging recent economic improvements. It said that increase in liquidations is a legacy of the recession and the period of exuberance before the recession.

"Higher real financing cost came about by default as inflation trended lower and nominal interest rates remained unchanged," said SACCI. The volatility of the exchange rate at present it said is primarily a function of the global financial flow of funds rather than a current account phenomenon.

"South Africa's highly developed financial markets provide a comfortable platform for these flows to take place over the short term providing the potential for substantial returns. Leads and lags on proceeds or payments of global trade transactions also exaggerate the volatility of the rand exchange rate," explained SACCI.

It said though the present rand strength was causing some discomfort, the reasons for the strength should be looked at before ill-conceived policy on intervention is implemented thereby contributing to economic distortions with potential unintended consequences for the economy. - BuaNews

Disability Management in the workplace

rovincial Treasury launched the Disability Forum on the 25 March 2009 at Golden Pillow. The purpose of the launch of the Disability Forum was to address issues that concerns affirmative action measures and disability management in the workplace.

These include issues such as training and development, provision of reasonable accomm-odation and promotion of persons with disability etc.

Transformation Services Directorate organised the first consultation process with the Disability Forum members at Vhembe SCM advice centres on the 27 May 2010 to discuss a first Draft Disability Policy for addressing the gaps that we have in the Department as the slogans says 'NOTHING ABOUT US WITHOUT US'.

Human Resource Development Directorate was involved in the process as part of addressing the skills gaps, Occupational Health and Safety Cocoordinator.

They also presented on issues of ergonomics, COIDA and emergency preparedness as part of wellness management, and awareness conducted on development of the Employment Equity plans and programmes linked to disability.

Various issues were discussed during the session.

It was agreed that structured training and development programme such as learnership and internship, workplace mentoring and coaching should be

provided. LPT will also provide modification or adjustment to a job e.g. job description, time-off for consultation and medical treatment), or the work environment.

The session also acknowledged that, generally, people with disabilities occupy the most junior levels within departments with more than 50% employed between level 1 – 5 and 40% employed between levels 6 – 9.

From the management level the representation drops sharply with 5.9% at levels 10 -12, 1.3% at levels 13 – 14 and 0.08% for Senior Management levels 15 – 16.

There should be a structured succession planning, including accelerated training programmes, retention strategies and others.

The employment of people with disabilities must not be confined to low

levels that involve very little decision making and authority.

Males with disabilities were more represented than their female counterparts at higher levels, with African women with disabilities being at the lowest ranks. This needs to be corrected in order to eliminate discrimination that has a double impact.

Further benchmarking with other institutions will be done

The challenges that people with disabilities encounter in the working environment were exposed:

- Assistive devices such as hand controlled vehicles for officials duties, voice activated software's and speaking lifts.
- Braille machines to produce Braille documentation.
- Access to ramps, gates, doors to turnstiles and automatic doors
- Evacuation procedures which take special needs into account.

Tender Advice Centres

tender Advice Center (TAC) is a government initiative that provides non-financial business support to small businesses such as assisting with the access of tender opportunities and completing tender documents. This is all areas including catering, stationary, furniture and construction organizations.

Contracts are normally awarded to suppliers who offer the best value for money, with regard to price, quality and other criteria applicable to individual contracts. Therefore, a TAC assists in providing guidance and explanations in respect of invitations to tender, assist in completing tender, documents, provide information on procurement and tendering policies as well as engage in awareness programmes. Primary during these sessions is the provision of a thorough and understandable meaning to tendering and what government expects from bidders.

These awareness initiatives are done in the form of workshops, seminars and forums.

Tender Advice Centres, further, educate suppliers in order to address the following issues.

- Provision of referrals and linkages of suppliers with relevant structures.
- Conduction and co-ordination of site, process and production line inspection.

When you want to complete a tender document you visit your nearest tender advice centre as they will help you get hold of and complete the tender document and/or check their monthly programme of workshops in your districts.

Through the TACs, Provincial Treasury is responsible for government tenders and the distribution of Tender Bulletins once the need has been identified. These bulletins are also available on the Provincial Treasury website (www.limtreasury.gov.za)

Tenderers are advised to visit their nearest Tender Advice Centre for completion of tender documents.

Tender Advice Workshop

osesetjane - Limpopo Provincial Treasury (LPT) together with Waterberg Tender Advice Centre branch (TAC) held a workshop for tender advice at Mosesetjane village in Waterberg District, on the 26th day of May 2010. The workshop started at 10h00 am at the Headmen's kraal.

The purpose of this workshop was to provide information to the community about tenders, also teaching and briefing those who desperately want to initiate and register their own

companies on how to tender.

Mr. Eddie Radzwiedane from Waterberg TAC was guiding them about; what a tender is? How to complete a tender bulletin or bid document and also provided some reasons and explanation about why most tenders are unsuccessful. He highlighted that many people might complain about their tenders being disqualified, which this is caused by common errors made like:

- Late submission of bid documents.
- Incomplete submission or unsigned bid.
- Non- compliance with special conditions.

"This is the key for a tender to be declared successful" he said. Members of the public were also given a chance to ask questions in order for them to get more clarity about tendering.

Everyone received a bulletin form and Mr. Radzwiedane teaches them how to fill that tender bulletin form.

Senior Manager for Tender Advice from head office, Ms Betty Malope was also part of the workshop. Officials from Communication Service unit also exhibited and distributed the departmental informational materials to

all people who attended the workshop and community of Mosesetjane as well.

The provision of these materials was meant to broaden and equip the people with information regarding what treasury is doing and its support for the publics.

It also helped to provide them with a direct contact or access to the department whenever they need to communicate or enquire about any other information concerning the department.

It was really an exciting moment for the community of Mosesetjane to meet government officials and make useful enquiries on services that government provides.



Tips for preparing a Tender

- 1. Identify a public sector market: you must know the core business.
- 2. Plan carefully: you need to select your tender carefully, develop a plan on how you will win and dedicate resources to winning.
- 3. Analsze requirements of the bid:
 Create a schedule of requirements:
 draw a check-list of all the
 requirements, always go through
 the documentation in detail and
 prepare a list of everything you must
 return for each section. Comply with
 specia conditions (if reflected).

Submit your bid documents on time. The bid must be signed adnd completed information.

- **4. Price to win:** review your pricing and have a clear plan to deliver value from this pricing.
- Make sure that you answer the questions honestly: make sure you are being realistic as you must be able to deliver.
- **6. Talk to the experts:** try to speak to a tender writer since they are able to

develop a well designed tender and will also help you find new tenders.

- 7. Remember first impression count: your tender should look professional and invest in making it look good.
- **8. Closing date and time:** make sure that you submit your bid before the official closing date.
- 9. Always be updated: check the tender bulletins regularly on both local and regional newspapers

BIDDING PROCESS FLOW

- Identification of a need by the department. Determination of the scope and output.
- Preparation of a bid (Compilation of specification/ determination of evaluation criteria).
- Approval of an intention to invite a bid by the Accounting Officer.
- Generation of bid documents
- Advertisement of a bid in the provincial tender bulletin and /or any commonly used local/national

- newspapers.
- Closure of a bid.
- Bid Evaluation: Evaluation of price and specific goals and or functionality)
- 1st phase of evaluation : Administrative compliance
- Second phase of evaluation: Calculation of price and preference points.
- Calculation of preferential/ specific RDP goals

- Inspections to confirm existence and capacity of the bidder to execute the contract (if necessary).
- Recommendations and evaluation report submitted to the Departmental bid committee for adjudication.
- Award endorsed by the Accounting Officer.
- Issuing of Acceptance letters/ signing of contract/Service level agreement



AUDIT REPORTS

ou always hear people talking about how well a department that has an unqualified report has performed with no qualification. Confused? These are the explanations to the Audit Report terminology:

Unqualified report – this is seen as a good opinion where the financial statements may be regarded as fairly reflecting the financial status of the department or entity.

Unqualified audit opinion with emphasis of matter is the least severe opinion. The financial statements may be regarded as fairly representing the financial status of the department or entity, but there are a number of issues that are cause for concern which are raised in the emphasis of matter.

Qualified report is a severe opinion where the auditor concludes that an unqualified opinion cannot be expressed. Further, the auditors express that the effect of any

disagreement with management, or limitation on the scope of the audit is not so material or fundamental as to require an adverse opinion or a disclaimer of opinion.

Adverse report is the most severe opinion which is expressed when the effect of a disagreement is material and fundamental to the financial statements. This is to a point where the auditor concludes that a qualification of the report is not adequate to disclose the misleading or incomplete nature of the financial statements.

Disclaimer is where the auditor does not express an opinion. It can be classified as a severe opinion where the auditor concludes that the possible effect of a limitation on the scope of the audit is so fundamental that the auditor is not able to obtain sufficient appropriate audit evidence to express an opinion on the financial statements.




